The "Granfondo Edita Pucinskaite - Rosti for Emergency" is a non-competitive cycling event (hereinafter also referred to as an event or improperly race). The event is dedicated to racing bikes (hereinafter also referred to as BDC). Given the non-competitive nature, the use of pedal assisted racing bicycles, as appropriate to the altitude complexity of the route, is also allowed.

The race is dedicated to the not competitive Cyclists and passes through characteristic roads and villages of the "Appennino Pistoiese" on asphalted roads with the aim of enhancing the landscape and local food and wine but above all to raise charitable funds of the non-governmental association Emergency; in particular for 2021 a part of the income will be dedicated to the "Italy Project"

The event received the patronage of CONI, the Tuscany Region, the Province of Pistoia, the Municipality of Pistoia, the Municipality of San Marcello-Piteglio, the Municipality of Abetone-Cutigliano, the Municipality of Marliana.

#### **ART. 1 – DATE & PLACE**

The race will take place on SUNDAY 20 JUNE 2021 in Pistoia, Italy

#### **ART. 2 - ROUTES AND DEPARTURES**

The "Granfondo Edita Pucinskaite - Rosti for Emergency" includes 3 different routes::

- **GRANFONDO "ABETONE"** 127 km, a competitive medical certificate for cycling is required
- **MEDIO-FONDO "SPIGNANA"** 82 km, a competitive medical certificate for cycling is required
- **FONDO "GERMINAIA"** 62 km, a NON-competitive medical certificate for cycling is required

Each participant could choose the path that best suits him and the choice must be indicated at the time of registration. It is however possible to change the type of route up to the moment of departure without any penalty between routes that require the same type of medical certificate, namely "Abetone" and "Spignana" (competitive medical certificate for cycling) and "Germinaia" route (NOT-competitive medical certificate for cycling)

The above is necessary both for logistical reasons and to verify the necessary medical certificate and may be limited or conditioned by the organization for technical and / or safety reasons.

In particular, there are limitations of liability for athletes under 18 or over 70 at the date of the event, see paragraph 4.

Minors aged 16 to 18, in addition to presenting a medical certificate and membership, can participate only if authorized by their parents or by those who exercise parental authority, the authorization form is available on the website at the regulation page.

The routes will be marked with specific signs. It is possible to download route plan, elevation and GPS tracks from the website [www.gfeditapucinskaite.com](http://www.gfeditapucinskaite.com).



The departure will take place in the "French" style from 07.30 to 08.10 from Piazza del Duomo, Pistoia. After this time, the timing service at the start will no longer be guaranteed.

#### **3.3 Ciclisti Stranieri**

For not Italian participants but duly registered with UCI, the rules referred to in point 3.1 apply (it means to have a valid medical certificate at the event date). Other FOREIGN cyclists can register by making the additional payment of € 10 for the automatic activation of the "A.C.S.I. supporting member card" which includes daily insurance coverage. It works only if participant will provide a valid medical certificate)

The Organization may at any time and at its sole discretion decide whether or not to accept the registration or to exclude a participant from the event if it could damage the image of the same.

Minors between 16 and 18 years, in addition to presenting a medical certificate and membership can only participate if authorized by their parents or by those who exercise parental authority, the authorization form is available on the regulation page

### **ART. 4 - REGISTRATION PROCEDURES AND COSTS**

Registrations open to everyone starting from 10/01/2021 at 09:00 in the manner described below:

- PROMOTION registration for the first 100 subscribers at € 15.00 available until 31/01/2021
- STANDARD registration open to all for € 25.00 until the 1500 numbers available are exhausted

The registration fee, regardless of the price paid, includes:

- The RACE PACKAGE with gifts and souvenirs of the event;
- The dorsal RACE NUMBER to attach to the jersey and the one for the bicycle;
- RESTAURANTS in different numbers according to the length of the routes;
- The PASTA PARTY at the end of the event; \*
- SHOWERS upon arrival. \*

\* Showers and Pasta Parties will be available in compliance with the ANTI-COVID19 ministerial rules valid at the date of the event. The organization will take care of appropriate communication in advance through the website or social network channels to participants regarding the possibility of using these services.

#### **ART. 5 - RESPECT OF THE ROAD CODE**

The "Granfondo Edita Pucinskaite - Rosti per Emergency" is a cycling event IN FREE EXCURSION on paved roads; the whole route will always be open to traffic and therefore it is mandatory for all participants to respect the International Road Code. It is also mandatory to have a kit for repairing faults and punctures and in particular the use of a helmet is mandatory (under penalty of disqualification)

#### **ART. 6 - VALIDITY OF THE REGISTRATION**

Registration can be considered regularly valid only after completing the electronic registration procedure with consequent electronic crediting of the amount in favor of the organizer. The insertion of the athlete's membership card entails the responsibility of the latter's president for the validity of the medical certificate. The organization of the event declines all responsibility for potential injuries or non-compliant health conditions of the athlete not covered by the insurance of the sports organization to which they belong. The DataHealth platform is active for FCI members.

The organization of "Granfondo Edita Pucinskaite - Rosti per Emergency" will be able, at any time and at its sole discretion, without the obligation of further motivation, to decide whether or not to accept anyone's registration.

#### **ART. 7 - SUBSTITUTIONS AND WAIVER OF PARTICIPATION**

With reference to the Event, it is possible to request the replacement of a participant within 21 days from the date of the Event only if the applicant is up to date with the registration, having sent the forms by that date and the registration fee. A secretarial contribution of € 5.00 will be required for this operation.

If a member does not participate in the event and has not sent a replacement request within the deadline set out in the previous paragraph, the participation fee will not be refunded and the race package will not be shipped.



However, within 21 days prior to the date of the event, the subscriber will be entitled to communicate the renunciation of participation only due to unexpected impossibility related to an injury documented by clinical reports by sending an e-mail to the following address [avisbikeptasd@gmail.com](mailto:avisbikeptasd@gmail.com). The clinical documentation will be treated in compliance with the current privacy legislation. After verifying the reasons for the cancellation and the related reports, the Organization will recognize the validity of the registration for the same event organized in the following year, without prejudice to the administration fee of € 5.00 to be paid during the registration period for the event of the following year. This registration valid only for the following year will however be nominal and not transferable to third parties. In case of further non-participation, the fee will therefore be considered lost.

It is therefore understood that in no case will the participation fee be refunded and in no case will the race package be sent.

#### **ART. 8 - COLLECTION OF RACE NUMBERS WITH IDENTITY DOCUMENT**

In Pistoia, in the Logistics Office that will be indicated on the event website, the RACE NUMBERS will be distributed before the event according to the following times:

- Saturday 19th June from 10.30 to 12.30 and from 15.00 to 19.30
- Sunday 20 June from 05:40 to 07:00

To collect the TECHNICAL PACKAGE and the RACE PACKAGE it will be necessary to present:

- The printing of the registration generated by the platform (or visualization in digital form on a smartphone)
- Competitive sports card or medical certificate pursuant to art. 3 of this regulation;
- Valid identity document.

To collect the TECHNICAL PACKAGE and the RACE PACKAGE it will be possible to "delegate" a friend or trusted person by delivering:

The print of the registration generated by the platform and DELEGATION duly completed and signed in original, the model can be downloaded on the regulation page. In addition, you will need:

- Copy of the identity document of the delegator;
- Copy of the competitive sports card or the original of the medical certificate pursuant to art. 3 of this regulation;
- Valid identity document of the delegate.

#### **ART. 9 - MAXIMUM TIMETABLE, CLOSING OF ROUTES, ASSISTANCE**

The maximum time to complete all the routes is set for 15:30

After this time, the Pasta Party and timing service will not be guaranteed

In the vicinity of the locality "La Lima", starting from 11:00 the deviation on the 82 km Medio-Fondo route (Spignana) will be mandatory

There is no health care, except for a S.O.S. emergency doctor 118 or by calling the emergency number +39 348 3468654. Mechanical assistance is not provided outside the points provided by the organization.

#### **ART. 10 - REFRESHMENTS, CHECKS AND ARRIVAL OF ROUTES**

Along the routes there are two types of refreshment and supply points:

- Refreshment points or water make-up points (marked with R in the gpx maps) equipped with drinks, sweet and savory food. Remember that both the RESTAURANT and DRINKS points will ALWAYS be FREE.

Opening / Closing of refreshment points, checks and technical assistance points:

- LE PIASTRE - 13.8 km - DRINKS - opening 7:20 am, closing 9:30 am.
- SPIGNANA - 36.0 km - RESTAURANT, and TECHNICAL ASSISTANCE - opening at 08:15, closing at 11:00;
- VOLPINO - km 52.5 (long route) - DRINKS - opening at 09:00, closing at 12:00;
- ABETONE - km 69.5 (long route) - RESTAURANTS and TECHNICAL ASSISTANCE - opening at 10:00, closing at 13:00;
- PRATACCIO - 51.5 km (medium route) 96.8 km (long route) - DRINKS - opening at 11.00 closing at 14.30;
- PISTOIA Logistics Headquarters Route arrival - PASTA PARTY - opening at 11:30, closing at 15:30;

#### **ART. 14 - CANCELLATION OR POSTPONEMENT OF THE EVENT**

Cancellation - If, due to force majeure, the event does not take place, the amount paid at the time of registration will not be refunded, but only the participation fee will be considered valid in the event of a request to register for the next edition. - They will behave non-respectfully of the environment such as throwing waste outside the spaces set up at the refreshment points and controls.

We appeal to the civic sense of all participants so that the territories along the route remain clean.

#### **ART. 17 - APPROVAL, CONSENT, AUTHORIZATION, ETC.**

By asking to participate in the "Granfondo Edita Pucinslaite - Rosti per Emergency" in any of the ways provided for in these regulations, each participant from the time of registration:

- He declares to have read and approved these Regulations and to accept all of its parts;
- He is the guarantor of his own behavior during and after the event;
- He declares to be in good physical condition and to be in good standing with a valid medical certificate after having undergone a medical aptitude examination for competitive cycling or cycling, providing the organization with the widest indemnity for any damage that may be suffered as a result of his participation in the event; We remind you that in the case of team registrations, the responsibility for this is attributed to the president of the association to which they belong.
- You consent to the use of your data, including for commercial purposes, in accordance with the provisions of the consolidated act on privacy no. 196 of 30/06/2003 and the European Union Privacy Regulation 2017/679 (GDPR / 18);
- Grants the organizers the widest possible consent to the use, in the ways permitted by law, including for profit, of any video or photographic image taken during the days of the event, providing the organization with the right to transfer such images to third parties.



The aforementioned authorization for the use of one's own image must be understood to be granted indefinitely and without territorial limits throughout the world, for use in various publications and films, including, by way of example and not limited to, promotional materials and / or advertising made on all media. The organization may also transfer the rights of use provided for in this agreement to third parties and its institutional and commercial partners.

The organization declines all responsibility for itself and its collaborators, for accidents or damage to people or things, which may occur before, during and after the event or as a result of it.

Upon registration, each participant declares to:

- To know the routes and to be aware of the risks deriving from or connected with the event, to have carefully evaluated them before registering.
- Be in possession of a competitive sports medical certificate to be able to perform the MEDIO-FONDO and GRAN FONDO course
- Be in possession of a medical certificate suitable for non-competitive sporting activities to complete the FONDO course
- In the event that the participants in possession of the non-competitive medical certificate decide, for any reason, to take the MEDIO-FONDO or GRANFONDO courses, they will do so under their own responsibility and in any case for the purposes of the ranking, only the scores deriving from the SHORT path
- The organizer will not be liable for damages and injuries that may arise to participants from participation in the event or caused by participants to third parties, due to: - collision with other participants, vehicles or stationary obstacles - the characteristics of the road surface, weather phenomena or any other cause not directly attributable to the conduct of the organizer; - physical conditions, health or conditions of the means of transport used for each participant.
- The organization declines all responsibility for events that occurred before, during and after the event and involving participants both among themselves and with third parties.
- The organization and the rescue personnel are not responsible in any way for bicycles or other materials abandoned, lost or stolen before, during or after the event and during rescue operations.
- The organizing company declines any responsibility in the event that third parties unrelated to the event create damage to themselves or to others, entering the event fraudulently or in any other way.
